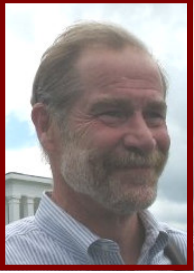

Dr. Jeffrey Boutwell is Executive Director of the Pugwash Conferences on Science and World Affairs. Dr. Boutwell is the author of numerous books and articles on a wide range of international security issues. Previously he was program director for international security studies at the American Academy of Arts and Sciences, staff aide on the National Security Council during the Carter administration in Washington, DC, and reporter/editor with the City News Bureau of Chicago.



Dr. André Brie is a Member of the European Parliament since 1999 for the Party of Democratic Socialism, part of the European Left and sits on the European Parliament's Committee on Foreign Affairs. He is also a substitute for the Committee on Petitions and the Committee on the Internal Market and Consumer Protection. 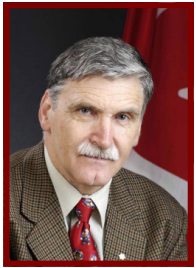
Martin Butcher is a consultant on international security issues and a NATO policy analyst for the Acronym Institute for Disarmament Diplomacy. He is author of a forthcoming briefing paper on NATO, Nuclear Weapons and Arms Control. He is also the author of *What Wrongs Our Arms May Do? The Role of Nuclear Weapons in Counterproliferation*. Martin has been a researcher on NATO and nuclear weapons issues since 1988 with the British American Security Information Council (in London and Washington DC), with the Centre for European Security and Disarmament (which he founded in Brussels), and with Physicians for Social Responsibility (in the United States).



Dr. **Raphael Masunga Chegeni** MP is in the National Assembly of Tanzania. He is also a PNND Global Council Member, Deputy Secretary General, Amani Forum of The Great Lakes Reg Parliamentary Forum (for Peace). He has a background in Financial Administration and a Docotrate from Washington International University. He is a member of Chama Cha Mapinduzi - CCM, the governing party in Tanzania.



Jeremy Bernard Corbyn is a British Labour Party politician and Member of Parliament for Islington North. He has been in the House of Commons since he won his seat at the 1983 general election. A long-time supporter of the Campaign for Nuclear Disarmament, he is one of its three Vice-Chairs.



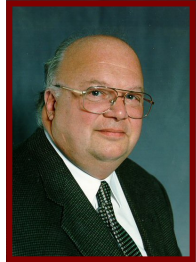
Lieutenant-General The Hon. **Roméo Dallaire**, O.C., CMM, GOQ, MSC, CD is the Honourary Patron of the Pugwash Peace Exchange and past commander of the United Nations Observer Mission—Uganda and Rwanda, for which he was awarded the Meritorious Service Cross. Since his retirement, Lt-Gen. Dallaire has continued to speak out on the politics of genocide, working to bring an understanding of post-traumatic stress disorder to the wider Canadian public. Since joining the Canadian Senate on March 24, 2005 Roméo Dallaire has actively promoted nuclear disarmament publicly and in the Senate.



Jonathan Granoff, President of the Global Security Institute, is also Senior Advisor of the American Bar Association's Committee on Arms Control and National Security. He is Vice President of the NGO Committee on Disarmament at the UN, and serves on numerous boards including the Lawyers Committee on Nuclear Policy, the Lawyers Alliance for World Security, the Jane Goodall Institute, the Bi-partisan Security Group, and the Middle Powers Initiative.



Marian Hobbs is New Zealand's former Minister of Disarmament & Arms Control and Minister for the Environment. New Zealand is considered a global leader on the issue of nuclear disarmament. She led off the general debate at the 2005 review of the Nuclear Non-Proliferation Treaty in New York. Minister Hobbs' portfolio also assigns her responsibility for New Zealand's Law Commission, National Library, Archives, Urban Affairs and she is associate minister for Foreign Affairs and Trade, Justice, and Biosecurity. She is a Co-President of the PNND.



Keith Hunter is the Warden of the Municipality of the County of Cumberland and a member of Mayors for Peace, an organization whose goal is to work internationally to raise consciousness regarding nuclear weapons abolition. He sits on the board of the Athol Forestry Co-Operative, the Nova Scotia Municipal Finance Corporation and the Federation of Canadian Municipalities.



Sergei Kolesnikov, M.D. is founder and First President of the Eastern Siberian Scientific Centre of Russian (former USSR) Academic Medical Science, Irkutsk, Russia. He is Head of the Science Department of the Institute of Paediatrics and Human Reproduction. Specializing in embryology, his work was recognized in 1994 by his inclusion in "5000 Personalities of the World," and in 1993 when he was included in "Who's Who in the World" and "Who's Who in Science and Technology."



Hallgeir Langeland is a Member of the Norwegian Parliament. He is also Deputy Head of the Norwegian delegation to the Assembly of Western European Union and a Member of the Standing Committee on Transport and Communications.



Senator **Abacca Anjain Madisson** is from Rongelap – an atoll in the Pacific which had to be abandoned due to radioactive fallout from nuclear testing. She has led the efforts of the Marshall Islands to receive compensation from the United States for the loss of land, environmental destruction and health problems in the islands resulting from the tests. She is a Co-President of the PNND.



Alexa McDonough was the first woman Leader of the Canadian New Democratic Party and is currently the New Democratic Party Critic for International Development, International Cooperation and Peace Advocacy. She has also been a leader in numerous national and international social action groups and human rights organizations. She is a Co-President of the PNND.



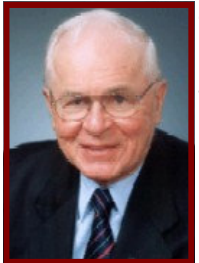
Paul Meyer has enjoyed a long and illustrious political career as a Foreign Service Officer, as Minister-Counsellor (Political) at the Embassy in Washington D.C. and later, as Minister and Deputy Head of Mission at the Embassy in Tokyo. He has since held a variety of positions at the Department of Foreign Affairs and International Trade. He was Director-General of the International Security Bureau from 1998-2001. From 2003 to 2007, he served as Ambassador and Permanent Representative to the Office of the United Nations and Conference on Disarmament in Geneva. In 2007, Ambassador Meyer became Director General of the Security and Intelligence Bureau at DFAIT in Ottawa.



Baroness **Sue Miller** was appointed to the House of Lords in 1998. She is the Liberal Democrat Spokesperson for Home Affairs, Chair of the All-Party Group on Street Children, a UK representative to the Inter-Parliamentary Union and member of the Liberal Democrat Federal Policy Committee. She campaigns on human rights, the environment and for a nuclear weapons convention. She has parliamentary links with Central and South American countries.



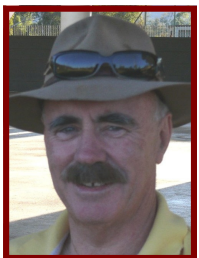
Marit Nybakk has been Chairman of the Standing Committee on Defense of the Norwegian Parliament since 2001. She was Member of the Enlarged Foreign Affairs Committee from 1997 to 2001. She is also currently a member of the Norwegian Delegation to the European Union. Ms. Nybakk has been Member of the Storting for Oslo on behalf of the Labour Party since 1987, and has been re-elected on four occasions. She previously served in the position of deputy representative during the term 1985–1989.



The Hon. **Douglas Roche**, O.C., is Chair of the Middle Powers Initiative, an international network of eight non-governmental organizations specializing in nuclear disarmament issues and is a member of the Pugwash Council. He was a Senator, Member of Parliament, Canadian Ambassador for Disarmament and past Chair of the Canadian Pugwash Group. He was elected Chair of the UN Disarmament Committee in 1988. He has authored 18 books and has received numerous awards, including the Mahatma Gandhi Foundation for World Peace Award and the United Nations Association's Medal of Honour.



Dr. **Erika Simpson** is an Associate Professor of International Relations at the University of Western Ontario. She is an executive of the Canadian Pugwash Group and is co-founder and director of the Canadian Forum for Global Security. Formerly, she was a Visiting Fellow at UBC's Liu Institute; an Alton Jones Fellow; a CIIPS Senior Barton Fellow; a DND Security and Defence Forum Fellow; and a NATO Fellow. Her current book project, *Nuclear Insecurity*, focuses on proliferation, deterrence, and disarmament.



Warren Edward Snowden is the federal member for Lingiari, Australia. Before entering politics, he worked as a researcher at the ANU, a school teacher and a policy officer at the Central Land Council. As a member of parliament, he has served as Parliamentary Secretary to the Minister for Transport and Communications (1990-2), Parliamentary Secretary to the Minister for Employment, Education and Training (1992-6), Parliamentary Secretary to the Minister for Environment, Sport and Territories (1993-6) and Parliamentary Secretary (Territories) (1993-4). He is currently the Minister for Defence Science and Personnel.



Steve Starr is a nuclear weapons expert from the United States and a member of Physicians for Global Survival. He has co-authored *Let's Go No-LOW* in the Bulletin of Atomic Scientists, and *Change Launch on Warning Policy*, published by the Moscow Institute of Physics and Technology, among numerous other articles.



Anne-Grete Strøm-Erichsen is the Norwegian Minister of Defence. She is a member of the Labour Party Central Council. Previously she has been chairperson of the city cabinet in Bergen, and also served as Councillor and Chairman of the Standing Committee on Environmental Affairs and Urban Development for the City of Bergen. She was Commissioner of the City of Bergen from 2003 until her appointment as Minister of Defence.



Hiromichi Umebayashi, a PhD holder in applied physics, is the founder and the President of the Peace Depot, a non-profit organization based in Yokohama, Japan. He also serves as the International Coordinator of the Pacific Campaign for Disarmament and Security (PCDS), a Pacific regional network for disarmament, the Editor-in-Chief of Nuclear Weapon and Nuclear Test Monitor, a bi-weekly Japanese publication which covers regional security and nuclear issues, a member of the Middle Powers Initiative (MPI) International Steering Committee, and the East Asian Coordinator of the Parliamentarian Network for Nuclear Disarmament (PNND).



Alyn Ware is Director of the Peace Foundation Wellington Office, Consultant for the International Association of Lawyers Against Nuclear Arms, International Coordinator of Parliamentarians for Nuclear Non-proliferation and Disarmament (PNND), and Vice-President of the International Peace Bureau. He serves on a number of boards and advisory groups, and is co-author of "Securing our Survival: The Case for a Nuclear Weapons Convention", drafting coordinator of the revised Model Nuclear Weapons Convention (now a UN document) and co-founder of the Cool Schools Peer Mediation Programme which has been introduced into over half of New Zealand schools.



Uta Zapf is the Chair of the Bundestag (German Parliament) Sub-Committee on Disarmament Arms Control and Nonproliferation, and is the Deputy Spokeswoman for Foreign Policy of the Social Democrats in the Bundestag. She has been a leader internationally on non-proliferation issues including most recently a parliamentarians' initiative to ensure that nuclear technology assistance to countries is conditional on their integration into non-proliferation and disarmament measures and mechanisms. She is a Co-President of the PNND.
